LETTER OF CONDITIONAL RECOGNITION

Sub: Regarding grant of conditional recognition for starting teacher education Courses.

In terms of Sections 14 (1) of the NCTE Act, 1993 the institutions mentioned in para 3 below had submitted applications to the Northern Regional Committee of NCTE for grant of recognition for starting teacher training programmes mentioned against their names.

- 2. The application submitted by the institutions mentioned in the table below seeking recognition from the Northern Regional Committee of NCTE for conducting teacher training programme as mentioned against their names in column 3 were scrutinized by the NRC in its 106th meeting held on 11-12 August, 2006 at NCTE Headquarters, New Delhi.

In view of the above, the committee decided to issue a conditional recognition to the above institutions and also advised to remove the deficiencies shown against their names and comply within 21 days from the date of issue of this letter.

3. The institutions all undertake to appointment the staff by a duly constituted selection of candidates possessing qualifications as selection of candidates possessing undiffications as received under rules. Therefore, the institutions are hereby issued a conditional recognition for further necessary action as per the NCTE Rules and Regulations for the commencement of the session 2006-2007.
