ORDER

WHEREAS in terms of Section **14(1)** of the NCTE Act, 1993 **Sri Guru Teg Bahadur College of Education Vill & Post - Khnakot, Dist. - Amritsar, Punjab**, had submitted an application to the Northern Regional Committee of NCTE, Jaipur for grant of recognition/permission for starting **B.Ed** Course of **One year** duration with an annual intake of **100 (One Hundred Only)** students on **16.01.2006**.

2. AND WHEREAS the original file of the institution as well as other documents and materials submitted by the institution along with VTR videography were duly considered by the NRC in its **106th Meeting** held on **11th to 12th August, 2006** the committee noted that the following compliance required to be made by the institution before the commencement of the academic session 2006-2007. **1). Appoint duly selected staff with the requisite qualification as per NCTE norms or standards and inform the Regional Committee.** Accordingly letter of Conditional recognition was issued to the institution vide NCTE letter no. **F.NO.NRC/NCTE/F-7/4937/ Dated 14.08.2006**.

3. AND WHEREAS the applicant institution did not comply with conditions mentioned in the conditional recognition to Northern Regional Committee, NCTE, Jaipur and the matter was placed before NRC in its **142nd Meeting** held on **14th to 16th June, 2009** and the committee decided to refuse the recognition for B.Ed Course of one year duration. Accordingly order was issued vide order no. **F.NRC/NCTE/F-3/PB-372/142 Meeting/2009/5370-77 dated 02.07.2009**. The above said institution, thereafter preferred an appeal dated **16.07.2009** to the NCTE, New Delhi. Under section 18 of the NCTE Act 1993 against the aforesaid order.

4. AND WHEREAS after perusal of documents, memorandum of appeal, affidavit and after hearing oral arguments advanced during the hearing, the NCTE, New Delhi, reached the conclusion that there was adequate ground to accept the appeal set-aside NRC's order dated **14th - 16th June, 2009** and remand back the case to NRC for re-examination of the staff profile and thereafter pass appropriate orders, in its order no. **F.No. 89-689/2009-Appeal/2231 dated 11.09.2009**. Accordingly, letter was issued to the institution vide order no. **F.NRC/NCTE/F-3/PB-372/2009/12051 dated 06.11.2009**. The applicant institution has submitted the representation to the Northern Regional Committee on **01.12.2009**.

5. AND WHEREAS the matter was placed before the committee in its **135th Meeting** held on **11th - 12th December, 2009** and the committee was decided to **grant recognition under clause 7(11) of Regulations 2007**.

6. NOW, THEREFORE, in exercise of the powers vested under Section **14(3) (a)** of the NCTE Act, 1993, the Northern Regional Committee hereby grants permission to **Sri Guru Teg Bahadur College of Education Vill & Post - Khnakot, Distt. - Amritsar, Punjab** for conducting **B.Ed Course of Secondary (Level) of One year** duration with an annual intake of **100 Students (One Hundred only)** students from the academic session **2009-2010** under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following conditions as per the clarification from the NCTE HQtrs letter No. File No. 48-3(1)/2008/NCTE (N&S) dated **01/10/2008**.

- ✓7. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- ✓8. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- ⑧ The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.

9. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

10. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

11. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.

12. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form ✓
- Land and Building Particulars ✓
- Staff Profile ✓
- Recognition letter ✓
- Information for having fulfilled the norms & standard and other required conditions. ✓

13. In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
